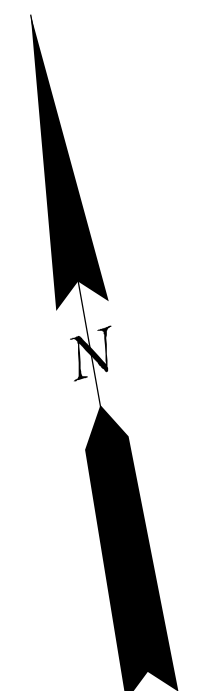
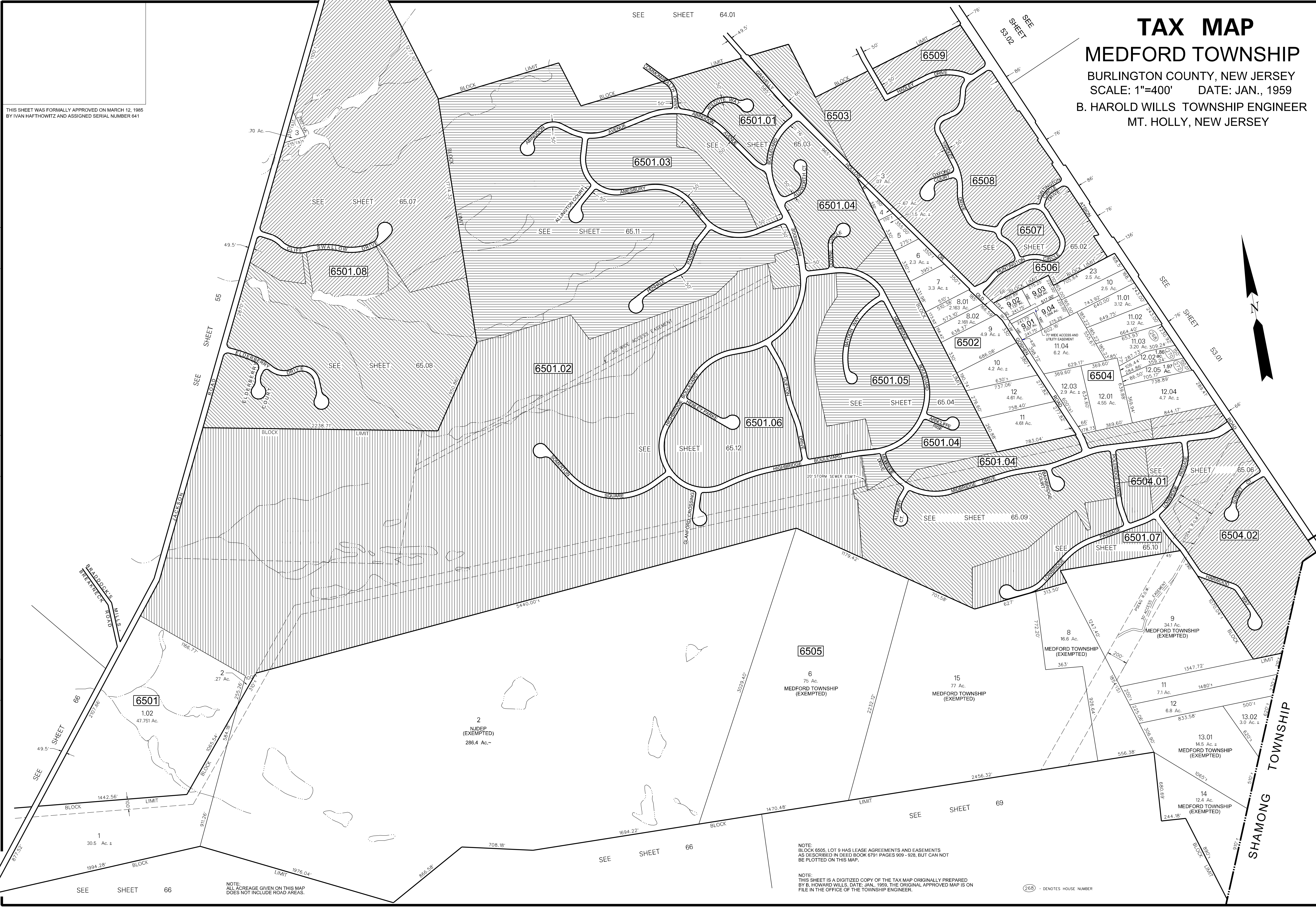


**TAX MAP**
